***Tournament Bulletin***

**General Information:**

The purpose of the District 1 & 2, 2A Volleyball Tournament is to seed District 1 & 2 teams into the 2A State Volleyball championships. three (3) teams will advance to the state championships on November 15 & 16, 2019 at Central Washington University in Ellensburg.

Twelve teams qualify to participate in the District 1 & 2 2A Tournament; The District 1 & 2 RPI system will be used to rank the top twelve teams in order. Where each team finishes based on their RPI will determine the order in which they are placed into the district bracket.

Teams 5 through 12 will play a first-round single elimination game at the higher seeds home court on Tuesday, November 5th. The losers of these contests are out. The winners of these contests will then be put into the eight-team double elimination bracket. The first round of bracket play will be conducted on Thursday, November 7, at Sammamish and Lynden High Schools. Where teams are plugged in to the double elimination bracket will be determined by the first-place finisher as determined by the RPI system. If the first-place finisher is a North team, they will play at Lynden H.S. If they are a South team, they will play at Sammamish H.S. The final round of bracket play will be completed on Saturday, November 9 at **Lynden High School** only.

**Tournament Policies and Regulations:**

The tournament shall be governed by the WIAA rules and regulations, District 1 & 2 policy, and NFHS rules. Each site will appoint a Tournament Committee which will be empowered to make decisions or judgments deemed necessary that are not specifically addressed in these instructions. Any item for consideration by the Committee must be submitted to the Tournament Manager or the local Site Managers.

### Directions to Sites:

- **Directions to Lynden High School: (1201 Bradley Road - Lynden, WA 98264)**

(Driving North or South on I-5) Exit 255; East Sunset Drive/WA 542. Drive East 1.0 miles to Hannegan Road. Turn left on to Hannegan Road. Drive 12 miles and as you come into Lynden, turn right on East Grover Street. Lynden High School is 1.0 miles on the right.

### Directions to Sammamish High School: (100 140<sup>th</sup> Ave. SE – Bellevue, WA 98005)

- Merge onto I-405 via EXIT 182 toward Bellevue / Renton. Take the SE 8<sup>th</sup> exit, EXIT 12 and go 0.22 miles and turn left onto SE 8<sup>th</sup> Street. Turn right onto Lake Hills Connector Road. Turn left onto 140<sup>th</sup> Avenue SE and go 0.6 miles and you will arrive at Sammamish High School.

### Bus Parking:

- 11/1 at Lynden High School-All buses enter the (first) parking lot and park in the marked bus lanes in front of the gym.
- 11/1 & 3 at Sammamish High School – Buses will drop off athletes at the front (west side / off 140<sup>th</sup>) of the school and then proceed to park behind the school (east side of the school / off of main street).

## **Admission Policies:**

### Ticket Prices:

### Passes:

District 1 or 2 **Event** Supervisors Pass and Lifetime passes will be the only ones accepted for admission. People using the Event Supervisor pass are expected to take an active role in their crowd management.

**\*Regular District 1 or 2 Coach/Supervisory Passes are NOT valid for post-season admission.**

## **Eligibility:**

- The school must be a member of the WIAA and enrolled in volleyball for the current year
- A participating student must meet all eligibility requirements set by the WIAA
- All players must be certified by the principal at the first state-qualifying tournament
- Official uniforms must be worn for all contests

## **General Guidelines:**

- The official's association will furnish scorekeepers and lines people at all sites. The tournament director will provide scoreboard operators and libero trackers at all sites.
- No signs may be posted except for the school banner, which must be approved by the tournament director.
- Noisemakers are not allowed.
- The bench area is restricted to the teams, coach, and managers.
- Teams may not provide their own warm up music.
- Concessions will be available throughout the tournament.
- The tournament director is empowered to make any decisions or judgments deemed necessary, that are not specifically covered by this bulletin

## **Gymnasium:**

- The gymnasium will open one hour prior to the start of first game of the day.

## **Home Team:**

- The home team is the higher seed, if no higher seed, then the bottom team in the bracket is the home team.

## **Locker Rooms:**

- Locker rooms will be provided for each participating team. Please check in with tournament director upon arrival.
- Showers are available, towels will not be provided.
- Security of all valuables is the responsibility of the participating school.

## **Warm-ups:**

Warm-up time will be 20 minutes, with 8 minutes for the home team, followed by 6 minutes for the visiting team, followed by 6 minutes for the home team. Warm-up time for all subsequent rounds will be 14 minutes; the home team will have the first 7 minutes. Teams will get 30 minutes from when the last game ends before the 7-7 count down warm up time starts.

**Match Schedule:**

- It is the coaches' responsibility to see that their team is near their assigned playing court at least 15 minutes prior to their match time

**Pre-Game Ceremony:**

- Welcome – WIAA sportsmanship announcement.
- The Pledge of Allegiance / National Anthem will take place prior to the first contest of the day.
- Introductions will take place before each contest.

**Officials:**

- The NW District Board will assign all officials for the District Tournament from the following associations: S.C.B.V.O and the N.W.B.V.O

**Rosters:**

- Your roster will serve as your pass list. Your playoff roster must be entered on the WPA website by **Thursday, October 31st**. The roster should include the names of the players (14 maximum), 6 designated school personnel, which includes, coaches, managers, statisticians, etc. 1 licensed health care provider/trainer for a total of 21 maximum people on your bench. Administrators, School board members & Superintendent should also be listed on your roster. When you post your playoff roster, please label it 2018 playoff roster and please do not include a team picture.

**Tournament Balls:**

- Tournament host is responsible for providing 3 NFHS approved game balls that are in good condition.
- Tournament host is responsible for providing warm up balls for all teams.

**Tournament Committee:**

- The tournament committee shall consist of the tournament director, the head official, a Cascade Conference/WESCO representative and a Northwest Conference representative.

**Ground Rules:**

- Ground rules will be explained at each site by the tournament manager or head official.

**Trainer:**

- There will be trainer available at both sites for all games.

**Filming**

- Filming is allowed from the bleachers only – NOT ON THE MAIN FLOOR.  
Bring your own accessories.

**Trophies:**

- A first-place trophy will be awarded to the District Champion.

**State Tournament:**

- Top 3 teams will advance to the state championships on November 15 & 16, 2019.
